I am writing in relation to your application made under the *Freedom of Information Act* 1991 (the FOI Act) in which you requested access to:

"House fire at on 24 May 2015

We act on behalf of Allianz, the insurer of the abovementioned property.

Pursuant to the Freedom of Information Act 1991, we request copies of all documents, reports and the like to the abovementioned incident and including, but not limited to:

- Incident reports;
- Investigation reports:
- Colour copies of all photographs; and
- Video footage of the fire and/or fire scene.

In the event the Fire Service Fire Cause Investigators (FCI) attended the fire, the above request is therefore also intended to include documents in relation to their investigation."

Fire Investigation Reports are obtainable under the *Fire and Emergency Services Act* 2005 on completion of the appropriate form (blank copy attached) and payment of the prescribed fee. Thus they are not documents that are obtainable under the FOI Act, section 20(1)(c) of the FOI Act.

I have conducted a search of files and located one (1) document that falls within the scope of your application. The document is identified in the attached schedule. In respect of the document, I have determined as follows:

#### **Document 1**

I have determined that this document should be released in part.



In regard to this document, the parts to which I have not granted you access are the occupant name, owner name and personnel numbers of firefighters.

- (i) The document contains the occupant name, owner name and personnel numbers of firefighters.
- (ii) It would be unreasonable to disclose the occupant name, owner name and personnel numbers of firefighters, but not the other information in the document.
- (iii) The occupant name, owner name and personnel numbers of firefighters are exempt from disclosure under clause 6(1), which reads:

"A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead)".

- (iv) In my view it would be unreasonable to disclose the occupant name, owner name and personnel numbers of firefighters because:
  - (a) Disclosure under the FOIA is "disclosure to all the world". (Re Sunderland and Department of Defence, (1986) 11 ALD 258; Re Williams and Registrar, Federal Court of Australia, (1985) 8 ALD 814; Re Anderson and the Australian Federal Police, (1986) 11 ALD 355.)
  - (b) Re Chandra and Department of Immigration and Ethnic Affairs, (1984) 6 ALN N 257, which has been applied in South Australia, says that I should consider "...all the circumstances including:
    - The nature of the information disclosed:
    - The circumstances in which the information is obtained;
    - The likelihood of the information being information that the person concerned would not wish to have disclosed without consent; and
    - Whether the information has any current relevance" (aN259).

The matters outlined in (a) to (b) above lead me to conclude that it would be unreasonable to disclose the occupant name, owner name and personnel numbers of firefighters under the FOI Act.

It is practicable to delete the occupant name, owner name and personnel numbers of firefighters and release the remainder and in accordance with subsection 20 (4) of the FOI Act, I have done so.

In accordance with Premier and Cabinet Circular PC045, if you are given access to documents as a result of this FOI application, details of your application, and the documents to which access is given, may be published in the agency's disclosure log.
