I am writing in relation to your application made under the *Freedom of Information Act 1991* (FOI Act) in which you requested access to the following documents:

"All documents relating to the fires that occurred at Endota Spa franchises in South Australia, including but not limited to incident reports, photographs, notebook entries, investigation reports, witness statements and fire logs.

The details of the fires are as follows:

- 1. Fire on 23 February 2017 at the Endota Spa located at Office 1B, Mawson Central 9-15 Main Street, Mawson, Lakes.*
- 2. Fire on 16 September 2014 at the Endota Spa located at 118 O'Connell Street, North Adelaide."*

In accordance with the requirements of Premier and Cabinet Circular PC045, details of your FOI application, and the documents to which you are given access, may be published in the agency's disclosure log. A copy of PC045 can be found at <http://dpc.sa.gov.au/what-we-do/services-for-government/premier-and-cabinet-circulars>.

Please note that in regard to your request for documents relating to a fire on 23 February 2017 at the Endota Spa located at Office 1B, Mawson Central 9-5 Main Street, Mawson Lakes (point 1 of your application), there is no record of a fire on that date at that address. A search was also conducted for 22 and 24 February with no results.

A search of files has been conducted, with regard to point 2. of your application, and five (5) files were located that are within the scope of your application. The documents are identified in the attached schedule.

In respect of each document, I have determined as follows:

Documents, 1, 2, 4 and 5

I have determined that these documents should be released in full.

Document 3

I have determined that this document should be released in part.

In regard to this document, the parts to which I have not granted you access is the name and mobile phone number of the owner of the building.

- (i) The document contains the name and mobile phone number of the owner of the building.
- (ii) It would be unreasonable to disclose the name and phone number of the owner of the building, but not the other information in the document.
- (iii) The name and mobile phone number of the owner of the building is exempt from disclosure under clause 6 (1) of the FOI Act which reads:

"A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead)."

- (iv) In my view, it would be unreasonable to disclose the name and mobile phone number of the owner of the building because:
 - (a) Disclosure under the FOI Act is "disclosure to all the world". (Re Sunderland and Department of Defence, (1986) 11 ALD 258; Re Williams and Registrar, Federal Court of Australia, (1985) 3 ALD 814; Re Anderson and the Australian Federal Policy, (1986) 11 ALD 355.)
 - (b) Re Chandra and Department of Immigration and Ethnic Affairs, (1984) 6 ALN N 257, which has been applied in South Australia, says that I should consider "... all the circumstances including:
 - The nature of the information disclosed;
 - The circumstances in which the information is obtained;
 - The likelihood of the information being information that the person concerned would not wish to have disclosed without consent; and
 - Whether the information has any current relevance: (aN259).

The matters outlined in (a) to (b) above lead me to conclude that it would be unreasonable to disclose the name and mobile phone number of the owner of the building under the FOI Act.

It is practicable to delete the name and mobile phone number of the owner of the building and release the remainder in accordance with subsection 20(4) of the FOI Act, I have done so. Accordingly, please find enclosed a copy of this document with the name and mobile phone number of the owner of the building deleted.

Appeal Rights

If you are dissatisfied with this determination, you are entitled to exercise your rights of review and appeal as outlined in the attached documentation.

Indicators.	Internal damage to contents of the dryer. Fire spread indicators supporting the point of origin. Deep charring to the bottom of the pile of towels within the dryer.
Fire Spread.	From the towels within the dryer, to the plastic dryer components, adjacent combustibles and up into the timber flooring of first floor above.
Structural Damage.	Ceiling collapse had occurred in the rear room with fire spreading to the timber flooring above. Plasterboard wall linings throughout the rear room had collapsed throughout.
Security.	The premises was secure when fire crews arrived.
Ignition Source.	Heat from the dryer.
Fuel Ignited.	Towels within the dryer.

INTRODUCTION


At 0429hrs on Tuesday the 16th September 2014, I, [REDACTED] Fire Investigator with the SA Metropolitan Fire Service (MFS) was notified of a fire that required investigation at Endota Spa, 118 O'Connell Street, North Adelaide. I liaised with SA Police (SAPOL) Fire Investigator [REDACTED] and we attended the scene at 0512hrs.

The building was a two storey stone building housing multiple business tenancies, with Endota Spa business occupying the ground floor northern most tenancy. At the rear of the tenancy on the second level, a vacant room was located, with timber flooring on timber joists with corrugated iron walls. This room was directly above the laundry room of Endota Spa.

Discussions with the business owners, [REDACTED] revealed the following information:

- [REDACTED] was the last known person in the tenancy, cleaning between 6.30pm and 8pm the previous evening, Monday 15th September.
- He put approximately 15 towels and a sheet in the dryer.
- At 8pm he turned the dryer off, opened the dryer door and left the building.
- The dryer had not completed its' full cycle and had approximately 10minutes to run. He left the towels and sheet in the drying tumbler drum with the door ajar.
- The spa business used organic oils, including macadamia and lavender oils.

INVESTIGATION

An **external** examination was conducted and the following fire damage was noted:

Front, western aspect:

Minor smoke staining was the only visible fire damage from the front of the business that opened onto O'Connell Street.

Northern aspect:

This aspect ran along George Street. Minor smoke staining was visible to the painted brickwork above the rear garage door. An inverted 'V' cut had been made by fire crews into the roller door, to gain access to the rear of the building during fire-fighting operations.

Southern aspect:

The southern side of the tenancy adjoined the neighbouring business within the building.

An **internal** examination proceeded from the area of least damage towards the area of most damage (area of fire origin). This commenced from the front of the business.

Front of the business

Fire damage to the front of the business was limited to smoke damage which increased in severity toward the rear of the premises. The office and front reception area suffered minor smoke staining. The glass front door had been forced open by fire crews during fire-fighting operations.

The treatment rooms: 'Breathe', 'Clarity', 'Harmony', 'Calm', 'Dream' & 'Believe' all suffered moderate smoke staining along with the hallway and waiting room.

The bathroom at the eastern end of the hallway suffered heavy smoke sooting. Partial ceiling collapse had occurred to the south eastern corner through water damage. The exposed ceiling space revealed charring to the flooring timbers above.


The kitchen/dining area at the rear of the business suffered heavy smoke staining throughout. Paint blistering was evident to the ceiling at the north eastern corner above the hallway leading through to the drying room at the rear of the building. The windows were heat cracked and the rear door had been forced open by fire crews to gain access to the rear of the business.

The rear drying/laundry room suffered the greatest fire damage. Ceiling collapse had occurred throughout with total consumption of ceiling joists at the rear of the room. Charred ceiling joists remained in situ at the entrance to this room. A 'V' burn pattern was noted on the rear wall originating at the washer dryer. The collapsed ceiling revealed deep charring to the 2nd floor timber flooring and joists above the dryer.

Area of fire origin:

Rear ground floor room of the tenancy, utilised as a laundry/drying room.

The area of origin was examined to determine the point of origin.

The fire damage radiated out from the Maytag combination washer dryer located against the back wall of the room. The appliance configuration had the front loader washing machine on the bottom underneath the gas fired dryer. Both machines had suffered significant fire damage with both doors being destroyed and the electronic control panels also destroyed by flame and heat. An inspection of the contents of both machines revealed the towels in the washing machine to have been singed on the exposed top surfaces which insulated the fabric beneath the top layer. The towels and linen in the dryer were burnt through to the bottom of the drum, consistent with a fire origin within the pile of towels (and sheet) left inside the drying drum when the cycle was stopped, (refer *Figures 3a & 3b*)

Fire spread patterns were consistent with a fire origin within the dryer, spreading to surrounding linen (towels/sheets), cabinetry and up into the ceiling space.

Point of fire origin:
Towels left inside the dryer.

Figure 3a: Internal view of the clothes dryer drum.





Figure 3b: Internal view of the clothes dryer drum, with linen removed.



Summary

Fire damage and fire spread indicators were consistent with a fire originating in pile of towels (& sheet) left to cool inside the dryer drum prior to the dryer completing its full drying cycle. Towels, with a high probability of containing residual organic oils from the spa operations, self-ignited assisted by the drying process and insufficient cooling following this process.

Cause: Accidental.






